## MINUTES OF MEETING

MONDAY 22 JANUARY 2024

In its consideration of items 1 to 3 below the Board deliberations were broadcast using the Council's webcast system. A copy of the webcast can be viewed [here](#).

### 1. Convenor's Update

Statement of Licensing Policy – the Convenor thanked everyone involved for the work done in ensuring the Board's new policy was completed and published. She acknowledged the requirement for the Board to assess overprovision, noting there was a report on the agenda to start that work.

Occasional licence referrals – with the Board's policy in place, the Convenor advised it was likely that referrals would form a regular agenda item. The priority would be firstly to focus on extended use of occasionals with no underlying provisional licence, and after that extended use of occasionals where there was a provisional in place.

Scheduling additional meetings – “fast-track Fridays” – the Convenor advised the Board there was a backlog of applications which would require to be considered by the Board. On that basis she was suggesting the trialling of a fast-track option for applications where it was considered they were more straightforward, where there were no objections and where statutory consultees had highlighted no issues. Until the summer, the Board would schedule additional meetings every month to deal with these applications, to be conducted using Teams.

The proposal was discussed in some detail and the Board agreed the proposal should be investigated further with a view to scheduling additional meetings on a trial basis.

### 2. Licensing Policy Statement – Assessment of Overprovision

The depute clerk narrated the terms of the report prepared for the Board on its requirement to carry out an assessment of overprovision. The Board noted the terms of the report and discussed how matters would be progressed. The Board agreed the following:-

- (a) to consider the details of licensed premises in the Board's area as provided by the Place Licensing Service;

- (b) to consider the details of representations received on overprovision during earlier policy consultations, from police and health representatives;
- (c) having previously agreed to do so, to carry out a consultation for an agreed period, inviting comment from statutory consultees and all other interested parties on the extent of licensed premises and capacities of premises provided by Place Licensing; and
- (d) to note that a follow up report will be required on the outcome of that consultation.

In addition, the Board agreed:-

- (e) to invite those who have submitted a representation already to determine whether they wish to update their remarks
- (f) to ensure community councils, the Licensing Forum, and any bodies who responded to the policy consultation, are advised proactively of the over-provision consultation starting; and
- (g) to delegate to the convenor and clerk to agree on the consultation questions which will be shared with members prior to going live for their comments, and to include a question on the level of geography and a reminder of licensing objectives.

### 3. Minutes of meeting of 27 November 2023, decisions and matters arising

The minutes of the meeting of 27 November 2023 were agreed.

### 4. Applications

The Board considered applications for major variations, new provisional premises licences, personal licences, occasional licences and provisional premises licence extension requests, all as detailed in the decision list appended to these minutes

### 5. Premises Licence Review Hearing – 48 Ferry Road Drive

The Board held a hearing on the terms of an application for review of premises licence submitted by Police Scotland. The Board heard from Sergeant Mercer, noted the terms of an LSO report provided by Veronica Macmillan and then heard from Alistair Macdonald on behalf of the licence holder.

The Board agreed at the conclusion of the hearing to issue the licence holder with a written warning and attach a condition of licence requiring the presence of an experienced staff member or personal licence holder on the premises during times when alcohol was being sold.

In granting such an extension, the Board must be satisfied in terms of [Section 45\(8\)](#) of the 2005 Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors outwith the premises licence holders' control.
- 2.5. Details of premises for which requests have been made will be attached to this report. Provisional licence expiry details will be confirmed at the Board meeting, if not set out as attached.
- 2.6. In some instances, the premises for which extensions have been requested have been operating by means of occasional licences issued by the Board, as permitted by the Act. The Board may wish to seek further information from licence holders and their agents, in the event of there being longer term use of occasionals, in line with the terms of the Board's newly adopted policy.

### 3. Recommendation

- 3.1 In the event the Board is satisfied with the reasons given, the Board is asked to reach a decision on the duration of any extension of the provisional premises licence for each of the requests.

## PREMISES LICENCE REVIEW HEARING – 79 Restalrig Road South, Edinburgh

### 1. Purpose

- 1.1 To advise the Board of the requirement to hold a hearing on a premises licence review application for the premises at 79 Restalrig Road South, Edinburgh.
- 1.2 To set out the options available to the Board, if it considers it necessary for the purposes of the licensing objectives, to take any action with the premises licence at the conclusion of the hearing.

### 2. Main Report

- 2.1. The grounds for review of a premises licence are:-
  - (a) that one or more of the licensing conditions has been breached;
  - (b) that having regard to the licensing objectives the premises licence holder is not a fit and proper person to hold the licence; or
  - (c) any other ground relevant to the licensing objectives:-
    - preventing crime and disorder,
    - securing public safety,
    - preventing public nuisance,
    - protecting and improving public health, and
    - protecting children and young persons from harm.
- 2.2. The Board may reject an application for review if it is considered that it is vexatious or frivolous, or that it fails to disclose matters relevant to the statutory grounds for review. The Board's Statement of Licensing Policy delegates this decision to the Convenor. The Convenor considered the application and agreed it should proceed to a review hearing.
- 2.3. The application has been submitted by Licensing Standards. The premises licence holder is Battista Property Ltd. A copy of the review application has been sent to them.
- 2.4. In carrying out the review hearing, the Board should first hear from the Licensing Standards as the applicant for review. The Board would then hear from the licence holder or their agent in response. At the conclusion of the hearing if the Board is satisfied that it is necessary or appropriate for the purposes of any of the licensing objectives the Board can take any of the following steps:-
  - (a) issue a written warning;
  - (b) make a variation of the licence;
  - (c) suspend the licence for such period as the Board may determine;
  - (d) revoke the licence.

### 3. Recommendation

  - (a) to hold a premises licence review hearing;
