Learning Estate Update: 2023 based School Roll Projections

2. Executive Summary

2.1 This report presents the latest School Roll projections and identifies actions that require to be taken or are in progress for individual schools.

3. Background

Overview

- 3.1 The Council is committed to updating and publishing school roll projections annually. The projections are used to identify schools where action may be required to address either rising or falling school rolls. They also inform the Education Infrastructure Appraisal associated with the Council's Local Development Plan Action Programme which identifies the timescales for extensions and new schools required as a result of city growth.
- 3.2 School Roll projections are the starting point for further analysis by the Strategic Asset Planning Team who assess future accommodation requirements and the impact of planned development.
- 3.3 The projection methodology is published on the Council's website. In order to identify future trends and estimate pupil numbers, the projections take into account the latest birth data available from the NHS; the most recent new housing delivery estimates; drop-off rates between year groups; and analysis of catchment and non-catchment placements.

4. Main report

Citywide Trend

Primary Sector

4.1 The overall Primary (P)1 intake has remained relatively static, dropping slightly from 3,993 P1 pupils in 2022 to 3,969 pupils in 2023 (-0.6%). The P1 intake in 2022 was the first time the P1 figure has been below 4,000 since 2010. The total primary roll has fallen for a seventh consecutive year, albeit with a smaller drop this year than

- previous years. This pattern is consistent with that observed in the birth rate for the city, which has fallen nearly every year since 2012 and would suggest that primary school rolls will continue to fall.
- 4.2 After an unexpected increase in births in 2022, the birth rate in 2023 has reverted to the downward trend seen in previous years. Averaging out the last five years has shown a year-on-year decrease in the birth rate of 3.48%.
- 4.3 The School Roll Projections are based on trends established in previous years. Accordingly, the latest projections project forward the downward trend experienced in primary school rolls in recent years. As a result, they continue to suggest a gradual citywide decline in primary school rolls until the end of the decade when the roll will begin to experience a gradual increase. However, this is attributable to growth forecast from housing development rather than an increasing birth rate. While it is anticipated that the birth rate will eventually begin to increase, it is not possible to say with any degree of accuracy when that may be although historic trends suggest births rise and fall over a 20-year cycle.
- 4.4 Significant housing sites on the edges of the city's existing urban areas, identified through the Local Development Plan (such as Cammo, Maybury, New Brunstane and Builyeon Road (Queensferry)), are all projected to be major catalysts for localised growth in these areas. It is anticipated that CityPlan 2030 will add to this growth beyond 2030.

Secondary Sector

- 4.5 In the secondary sector, reflecting the growth experienced in the primary sector from 2009 to 2018, the overall roll continues to increase. The overall secondary roll in 2023 was 23,150 pupils, the highest since the 1980s. This continues the significant turnaround from when the secondary sector experienced a 22-year low of 18,145 pupils in 2016. The overall secondary roll in 2023 increased 3.71% compared to the previous year.
- 4.6 The Secondary School Roll projections suggest that the overall secondary roll will continue to rise until it peaks in 2029. However, analysis of the relationship between previous primary and secondary roll peaks and troughs suggest that this peak may occur sooner than the projections predict possibly 2025 or 2026. As is the case in the primary sector, it is likely that the decline after this peak, whenever it occurs, is likely to be less pronounced than it might otherwise have been due to populations arriving from new housing developments.

Analysing Individual Projections

- 4.7 Analysis continues to show that there is a strong correlation between the birth rate across the city and the number of P1 pupils coming forward five years later.
- 4.8 The projection methodology used by the Council is applied consistently across all schools. However, the strength of the correlation between births and P1 pupils and other factors will vary at individual school catchment level. Local issues (such as changing demographics, housing development and catchment boundary change) all

present a challenge when considering projections at an individual school level. Other factors (such as parental choice, stay-on rates, the denominational and non-denominational split and the independent sector) compound these challenges further. One issue currently being analysed is the potential for increases in school capacity which may be required in the future if VAT is added to school fees in the independent sector and this means additional pupils will require to be accommodated in the Council's learning estate. Part of this process will be scenario planning using the new school projections. Briefings for elected members will be provided as necessary as this workstream progresses.

4.9 Accordingly, rather than relying on projections to provide absolute figures, the approach taken when assessing the roll projections is to treat them as an indicator of potential accommodation issues and, where a potential issue is identified, progress one or more of the following actions: Monitoring, Investigation or creation of a Working Group. More details of these actions can be found in section 4.10 of the report School Rolls considered by Committee in March 2021.

New Actions to Progress in 2024

- 4.10 The majority of actions arising from the 2023 School Roll Projections are not new and are addressed by 'Live' projects. 'Live' projects are those that have already been commissioned or are in the pipeline. The Learning Estate Update to Committee on 27 April 2023 provided updates on many of the 'Live' projects and reference should be made to this report for further information on these projects.
- 4.11 Appendix 1(c) of this report provides some commentary on schools where significant variation has occurred compared to the previous year's projections including details of what actions have been taken or could be set in motion.
- 4.12 A review of capacity in secondary schools is also continuing. This review seeks to make more efficient use of the spaces schools currently use. This involves detailed work with each secondary school to improve building information held centrally and to update capacity figures based on a methodology of 70% frequency of use efficiency for timetabled spaces. Various factors need to be considered alongside these calculations including suitability of social and dining space, toilet provision and circulation.
- 4.13 Provisionally, the overall increase achieved through the capacity review is the equivalent of an additional 3,700 places across the school estate. To construct this number of spaces through new schools and/or extensions to existing school would cost an estimated £131m.
- 4.14 For strategic planning purposes these planning capacities have been noted in Appendix 1(b). A briefing session for elected members on the implications of the capacity work will be provided once it has been finalised across all the secondary learning estate.

5. Next Steps

5.1 Appendix 1(c) provides further information on actions being taken forward and projects already under way.

6. Financial impact

- 6.1 Any financial implications as a result of rising school rolls will be captured in the annual review of the Capital Investment Programme.
- 6.2 Any proposals for additional capacity that would require physical changes to the school estate building will be the subject of a business case.

7. Equality and Poverty Impact

7.1 The are no equality, human rights (including children's rights) or socio-economic implications arising from this report. Any proposals for change within the school estate as a result of rising or falling school rolls will include an Integrated Impact Assessment as part of that project.

8. Climate and Nature Emergency Implications

- 8.1 School Roll Projections are a tool in the strategic management of the Council's estate. The projections highlight areas of growth, decline and change and inform investment decisions that seek to improve the efficiency of the school estate by making best use of available capacity and maximising value where investment in the school and wider estate is required.
- 8.2 Any new investment in the school and wider estate would be undertaken according to the principles set out in the <u>Corporate Property Strategy</u> which has net-zero and the decarbonisation of the existing estate at its core.

9. Risk, policy, compliance, governance and community impact

- 9.1 Appendix 1(c) outlines the actions being taken at individual schools to address the pressures that school roll projections may suggest. This includes engagement with school communities and the development of consultation work.
- 9.2 Where necessary Working Groups consisting of Learning Estate Planning Officers, School Management and Parent Representatives will be formed to consider the right solution for the accommodation pressures the projections may suggest.
- 9.3 Any statutory consultations will be conducted in line with the procedures set out in the Schools (Consultation) (Scotland) Act 2010 as amended by the Children and Young People (Scotland) Act 2014.

PRIMARY

School	Action(s) Proposed	Status
Castleview Primary School	LDP: New Greendykes PS	Early work to develop proposals for a new primary school in the Greendykes area of the city are underway. This work is focused on identifying an appropriate site for a new school. Initially stages of public engagement have been undertaken and this will be expanded prior to the summer.
Deanpark Primary School	LDP: Extension	Work to extend Deanpark Primary School and replace classrooms in temporary units is currently underway. The new classroom building has secured planning permission (22/06325/FUL) and the construction contract will be tendered shortly. Anticipated completion date is in May 2025.
Fox Covert RC Primary School	CityPlan 2030: New School	New housing developments in the west of the city at Maybury and proposed sites in the CityPlan 2030 around the airport are within the catchment area of Fox Covert RC Primary School. A new Roman Catholic Primary School in this area of the city has been identified as a requirement in the CityPlan. Until this provision is made, the roll at Fox Covert RC Primary School will be monitored and temporary measures applied as required.
Frogston Primary School	LDP: Extension	Frogston Primary School was designed to be extended to meet anticipated demand from the new housing developments it serves. This demand has been generated sooner than anticipated and work is under way to deliver the school extension.
Gilmerton Primary School	LDP: New School	Early work to develop proposals for a new primary school in the Gilmerton area of the city are underway. Initially stages of public engagement will begin in April 2024 after the Easter break with plans for a statutory consultation after the summer.
Hillwood Primary School	LDP: Extension	Projections do not show significant growth at Hillwood Primary School. However, officers believe that the projections understate the impact of new housing in the area and plans to increase Hillwood's capacity will be developed with the school community prior to summer 2024.
Maybury Primary School	Monitor	Maybury Primary School will open in August 2024 with a P1 intake only. Projections show the school exceeding its capacity by 2030. The growth of new schools is challenging to forecast. Accordingly, the growth of Maybury PS will be monitored and proposals to address any accommodation pressures developed at the appropriate time.
Newcraighall Primary School	Monitor	Delays in the delivery of the new Newcraighall Primary School are linked to delays in the delivery of new housing in the development site. Pupil generation from the delayed new housing is still factored into projections suggesting that the projections are overstated.

		However, higher P1 intakes mean growing pressure on Newcraighall Primary School and plans for the delivery of temporary accommodation are in development in case they are required as an interim measure.
Pirniehall Primary School	LDP: New School	Early work to develop proposals for a new primary school in the Granton Waterfront area of the city are underway. Initially stages of public engagement will begin in April 2024 after the Easter break with plans for a statutory consultation after the summer. The new school is planned for delivery in August 2028 and will take pressure off Pirniehall Primary School.
Queensferry Primary School	LDP: New School	The establishment of a new primary school at Builyeon Road in Queensferry and catchment changes to take pressure off Queensferry Primary School were approved by Council in February 2024.
		The creation of temporary classrooms in the Early Years annexe of the school will provide additional capacity until the delivery of the new school. A long-term plan for the permanent expansion of the school is being developed as part of a master-planning exercise considering opportunities to create a community hub and improved Council and partner service provision in Queensferry.
