1. Convenor's Update

The Convenor welcomed everyone to the meeting and explained the Board would be recorded for the full meeting and broadcast for business section only via the Council's website to ensure transparency. She explained the Council is a Data Controller and explained how the data is controlled by the Council.

The Convenor mentioned the unfortunate cancellation of the Hogmanay events due to inclement weather and she wished to pass on her gratitude to employees who helped facilitate events taking place at different venues at short notice.

The Convenor mentioned over provision and thanked Members for attending the two business meetings on the 10 and 17 January where all responses were considered in order to commence a second consultation.

She mentioned occasional licences and advised that in February she will gather any queries or concerns members may have and duly write to the Scottish Government with the views of Members.

She referred to Councillor Booth's query regarding applications and she advised it has been agreed with officers that any changes/amendments etc made at the Board will be captured and provided to Members in relation to over provision areas. She also stated a manual review of a sample of Board decisions from last year will also take place.

The Convenor said she intends to introduce additional Boards on a Friday to ensure all Board work is up to date and dates will be advised in due course. The Convenor referred to the Best Bar None awards night on 28 November 2024 and she thanked the other Members of the Board who attended the evening. She advised it is a great event to honour the incredibly high standards that premises in Edinburgh work towards to be the best. She also mentioned her congratulations to all licensed premises who received awards at the event.

2. Update on Over-provision policy progress, discussion on briefing and next steps

The Convener advised she wished to put on record that she recognises that there is a split between Members as to whether over provision should be retained as part of the policy. She advised that after the second consultation Members will be afforded the opportunity to decide on the retention of over provision.

She advised that the Members had decided to remove 2 localities that are deemed over provision localities in the current policy and that other localities have now been identified as potential over provision localities, and the consultation will seek responses on the proposed areas being adopted as over provision localities or not.

A discussion took place as to whether a discussion on over provision should take place at the end of hearing the applications on the agenda. The Convener asked for a brief discussion on Members views before deciding to continue until later. After discussion it was agreed to revisit over provision after Board business was completed in relation to applications.

3. Business Bulletin

The Depute Clerk advised that the purpose of the bulletin was to inform the Members of the number of applications processed by the licensing team. He explained it was a case of noting the report and advised Members that if there was any additional information they wished to see then he could ask for the details to be provided.

Report was noted.

4. Approval of Licensing Board dates for 2025/26

The Convener advised it has been suggested that additional Board meetings take place in July and December to ensure applications can be processed timeously. An agreement was put in place for the Board to convene in both months but with the December Board having a cut off time of 12 Noon.
