# Item 7.1 Spaces for People: East Craigs Low Traffic Neighbourhood

#### Committee:

Welcomes the changes made to the original East Craigs Low Traffic Neighbourhood proposals to better reflect local residents' concerns

Recognises that Low Traffic Neighbourhoods can be a valuable component of a city wide transport network, particularly for keeping through traffic away from primarily residential housing areas and facilities such as schools where improved safety conditions are desired. Requests a widening of the proposed eastbound bus gate operational hours to 15.00 -18.30, as well as the proposed 07.30 - 09.30 morning time period, to better reflect school hours and reduce traffic volumes during these times.

Requests further explanation, directly to Committee members and stakeholders, of possible traffic calming measures to be employed on Craigs Crescent and Craigs Avenue. Recognises that Spaces for People measures are many and varied and are therefore at different stages of implementation and monitoring.

Notes the intention to bring some schemes back for review and information to the next Transport and Environment Committee and that this is expected, for different schemes, at each T&E committee for the duration of the initiative.
